We declare the particulars to be correct and, in the event of any changes rendering invalid at any time any of the information given hereunder, or of our business ceasing to be qualified as a member, we undertake, if enrolled, to advise the Association forthwith. We enclose a certificate duly signed by our Chartered Accountants declaring our Annual Turnover.

Note: as a condition of acceptance the Board of Management of PRCAI may require occasional further information from members to form the basis of umbrella surveys published in the interest of consultancy practice. The Board guarantees the source and identity of all such information will remain confidential within the Association.

Signatures: in case of a partnership all partners must sign and in the case of a limited company at least two directors are required to sign.

PRCAI will take all reasonable precautions to prevent any unauthorised disclosure of such Confidential Information. This clause shall survive the termination, expiration or cancellation of membership but shall not apply to any information which:

- a) Is in the public domain as of the date of receipt by PRCAI
- b) Hereinafter become known to the public through no fault of PRCAI
- c) The disclosure of which is required by any applicable law, in which case, PRCAI shall immediately notify the disclosing party and cooperate in efforts to limit or avoid disclosure, if requested by the disclosing party.
